Subject:- Conduct of interviews for Class –IV posts advertized vide advertisement Notice No. 1 of 2006 dated 22.03.2006- Constitution of committee thereof.

ORDER

Whereas, recruitment process for 75 Class-IV posts of different Departments available in District Rajouri was undertaken under advertisement Notice No. 01 of 2006 dated 22.03.2006 in terms of Govt. order No. 42-GAD of 2006 dated 09.01.2006; and

Whereas, the recruitment process could not be finalized owing to various reasons and necessary clarifications/directions were also sought from the General Administration Department from time to time to conclude the recruitment process; and

Whereas, General Administration Department vide Govt. order No. 664-GAD of 2013 dated 23.04.2013 issued directions that the selection process be carried out afresh in a strictly time bond manner only for the candidates who had applied in pursuance of 2006 advertisements and the candidates shall not be barred for crossing the maximum age bar and shall be given deemed relaxation; and

Whereas, a number of applicants have approached the Hon'ble Court and Hon'ble High Court of J&K has passed the following direction:-

- I. SWP NO. 1365/2017 titled Pervez Ahmed V/s State & Ors. Order dated 31.05.2017”meanwhile, as ad interim and subject to objections, the selections process pursuant to Advertisement Notice No. 01 of 2006 dated 22.03.2006 shall remain subject to outcome of further orders in this writ petition.
 - II. SWP No. 14529/2017 titled Hem Raj and Ors V/s State and Ors. Order dated 07.06.2017..... Meanwhile, subject to objections, it is ordered that the respondents may go ahead with the selection process with regard to the post in question but the same shall not be finalized till further orders from this court; and

Whereas, vide Notification issued by this office under endorsement No. Estt/Adv/104-28 dated 22.05.2017 & Endorsement No. Estt/Adv/221-45 dated 01.07.2017, all the candidates who had applied in response of notification No. 1 of 2006 dated 22.03.2006 were asked to re-submit their education qualification certificates attained as on 15.04.2006; and

Whereas, such candidates have re-submitted their marks card/ education qualification certificate attained as on 15.04.2006 and it is imperative to proceed further in the matter in consonance with Govt. order No. 664-GAD of 2013

dated 23.04.2013 and aforementioned directions passed by the Hon'ble High Court of J&K, Jammu; and

Now, therefore, in view of the above, District level selection committee comprising of the following officers is hereby constituted under the chairmanship of undersigned to conduct the interview cum document verification to expedite the recruitment process initiated under advertisement Notice No. 1 of 2006 dated 22.03.2006 as per the schedule already notified by this office under endorsement No.
